Albanese, Acting Superintendent of Financial Services of the State of New York as Conservator ("Conservator") of Northumberland General Insurance Company ("NGIC 41 Trust"): (i) authorizing the Conservator to distribute the Conservation Assets to the NGIC Liquidator, for the benefit of NGIC; (ii) terminating this conservation proceeding upon distribution of the Conservation Assets to the NGIC Liquidator without further order of this Court; (iii) discharging and releasing the Conservator, his predecessors and successors in office, his agents, attorneys and employees from any and all further liability arising from this proceeding upon distribution of the Conservation Assets to the NGIC Liquidator; and (iv) providing for such other and further relief as this Court deems just and proper.;

NOW, upon reading the affirmation of Jack A. Franceschetti, in support of said motion dated November 9, 2015, with due proof of service thereof upon the NGIC Liquidator, and due deliberation having been had thereon, and upon the decision of this Court;

NOW, on application of John Pearson Kelly, Esq., Attorney for the Conservator, it is ORDERED, that the motion is granted; and it is further

ORDERED, that the Conservator is authorized to distribute the Conservation Assets to the NGIC Liquidator, for the benefit of NGIC; and it is further

ORDERED, that the within Conservation Proceeding is terminated and closed upon distribution of the Conservation Assets to the NGIC Liquidator without further order of this Court, and it is further

ORDERED, the Conservator, his predecessors and successors in office, his agents, attorneys and employees, upon distribution of the Conservation Assets to the NGIC Liquidator, are released and discharged from any and all liability arising from this conservation proceeding.
