

Upon the foregoing papers, the application by petitioner, brought by Order to Show Cause, for an order amending the Order of Liquidation, dated November 17, 2011, to include a stay of all third-party actions or proceedings against Washington Title Insurance Company ("WTIC") and against other persons or entities that WTIC is required to defend under its insurance policies, for a period of 90 days, is granted only to the extent directed below.

The Order of Liquidation, dated November 17, 2011, is amended only to the extent that all parties to actions, lawsuits, and special or other proceedings in which WTIC, its policyholders or insureds are obligated to defend a party or to provide a defense of any matter insured against pursuant to an insurance policy, bond, contract or otherwise, except for those actions which were carved out of the stay pursuant to the so-ordered stipulation dated November 29, 2011, are enjoined and restrained from proceeding with any discovery, court proceedings or other litigation tasks or procedures, including, but not limited to conferences, trial, applications for judgments, or proceedings on settlement or judgment, for a period of forty-five (45) days from the date of this Order.
