Upon the affirmation of David Axinn, dated March 1, 2022 ("Axinn Aff."), Special Deputy Superintendent of the New York Liquidation Bureau, which serves as the staff for the Superintendent of Financial Services of the State of New York in her capacity as liquidator ("Liquidator") of Health Republic Insurance of New York, Corp. ("Health Republic"), and upon all other papers previously submitted and all proceedings heretofore had herein;

NOW, on motion of the Liquidator, and after due deliberation having been had thereon,

LET all claimants and all interested in the affairs of Health Republic, <sup>OR THEIR COUNSEL,</sup> show cause before **via Microsoft Teams** the Court at IAS Part 35, ~~Room 438~~, 60 Centre Street, New York, NY 10007 on the 12th day of April, 2022 at 10 o'clock a.m. ("Return Date") or as soon thereafter as counsel can be heard, why an order substantially in the form of the proposed order attached as Exhibit A to the Axinn Aff, should not be made (1) approving the Release Agreement between the Liquidator and the United States; and (2) for such other and further relief the Court deems just and proper;

AND, sufficient cause having been alleged therefor it is hereby

ORDERED, that the Liquidator shall give notice of this application by: (i) posting this Order to Show Cause and its supporting papers on the Health Republic Internet web page at <http://www.healthrepublicny.org/> and on the Legal Estates and Notices Section of the Internet web page maintained by the New York Liquidation Bureau at <http://www.nylb.org/> within five (5) days of the entered Order to Show Cause being posted to the New York State Courts Electronic Filing (NYSCEF) system; and (ii) publishing the notice substantially in the form attached as Exhibit D to the Axinn Aff in the *New York Post* or a publication of similar circulation, at least ten (10) before the Return Date; and it is further

ORDERED, that answering papers, either in support of or opposition to the relief sought herein ("Answering Papers"), be served on the Liquidator by electronic mail or overnight carrier at the following address:
