ORDER

Upon the September 15, 2017, affirmation of Lauren M. Reber ("Reber Aff"), an attorney with the New York Liquidation Bureau the organization that carries out the duties of Maria T. Vullo, Superintendent of Financial Services of the State of New York as Ancillary Receiver (the "Ancillary Receiver") of Lumbermen's Underwriting Alliance ("LUA"), for an order approving the Ancillary Receiver's report attached as Exhibit 1 to the Reber Aff ("Closing Report") and the financial transactions delineated therein and for an order closing this ancillary receivership proceeding ("Ancillary Receivership Proceeding"), and upon all other papers previously submitted and all proceedings heretofore had herein;

NOW, on motion of the Ancillary Receiver and after due deliberation having been had, it is

ORDERED, that the application is granted; and it is further

ORDERED, that the Closing Report and financial transactions delineated therein is approved; and it is further


ORDERED, that the Ancillary Receiver is authorized to continue paying administrative expenses, including such expenses for the closing of the Ancillary Receivership Proceeding; and it is further

ORDERED, that the New York Liquidation Bureau is authorized to receive and disburse to the New York Workers' Compensation Security Fund (the "WC Fund"), any future distributions from the Director of the Department of Insurance, Financial Institutions and Professional Registration of the State of Missouri in his capacity as Liquidator of LUA in payment of amounts owed to the WC Fund without further application to this Court; and it is further

ORDERED, that the Ancillary Receivership Proceeding is terminated and closed; and it is further

ORDERED, that the Ancillary Receiver, her predecessors and successors in office, and their agents, attorneys and employees, are released and discharged from any and all liability arising from their acts or omissions in connection with the Ancillary Receivership Proceeding.
